After careful examination of the proposals received from the Madal Educational Officer, Kankipadu vide reference 3rd cited and also considering his recommendations and as per conditions prescribed in Govt. orders 1st read above, the competent authority i.e., the District Educational Officer, Krishna, Machilipatnam is hereby accords opening permission to Pre-Primary classes on par with the Primary Classes from the academic Year 2020-2021 in respect of "St.Mary's Primary School(EM),D.No:9-62,Kankipadu Village & Mandal ,Krishna District" without aid subject to the following conditions:

- 1) that the society shall abide by the instructions/rules and regulations made by the Government of authorized Officer from time to time.
- 2) that the Educational Institution shall serve the needs of the locality more particularly.
- 3) that the Instructions shall adopt the curriculum and syllabus prescribed from time to time.
- 4) that the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
- 5) that the qualified staff within the age limits prescribed by the Government for Govt. Employees shall be appointed as per the staff pattern.
- 6) that the results of the institution shall be satisfactory every year.
- 7) that the records/accounts shall be furnished to the District Educational Officer every year by July at the latest.
- 8) that the list of Governing Body shall be furnished to the District Educational Officer every year.
- 9) that the pay structure/fee structure fixed by the Governing body shall be get approved by the District Educational Officer every year.
- 10) that all the conditions prescribed in the G.O.s and other orders which are not specified in this orders shall be complied with.
- 11) that the society shall submit proposals for renewal of recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the permission.
- 12) Pre-Primary Schools are classified as Nursery, kindergarten, Montessori, and the like. They shall admit children who are in the age group of 3 to 5 years.
- 13) that the Teacher pupil ratio in respect of the Pre-Primary Schools shall not exceed 1:20 and in respect of all other sections the ratio shall not exceed 1:40.

In the reference 2nd read above, the Government of A.P have enhanced the recognition period from (3) years to (8) years, duly amending the Andhra Pradesh Right of Children to Free and Compulsory Education Rules, 2010 issued in G.O.Ms.No.20, School Education (PE-Prog.I) Department, dated 03.03.2011 and inserting certain guidelines after clause (1) in Sub rule (4) of Rule 14 of the said G.O and the same was communicated by the Commissioner of School Education, AP, Amaravati in the reference 3rd read above.

In the reference 4th read above, the Government of AP have accorded permission to extend the recognition of the schools from 03 to 08 years those who have already taken recognition for a period of 03 years, to comply the orders dated 11.08.2023 of the Hon'ble High Court in W.P.No.18190 of 2023 and the same was communicated by the Commissioner of School Education, AP, Amaravati with a request to take necessary action accordingly in the reference 5th read above.

Previously, renewal of recognition has been accorded to **St.Mary's EM High School, D.No.9-62, Rs.No.134&135, Kankipadu (V&M), Krishna District** to the **classes VI to X (EM)** for 03 years from 2022-23 to 2024-25 in the reference 1st read above.

Now the Correspondent, **St.Mary's EM HS, Kankipadu** has requested for extension of renewal of recognition to the classes **VI to X (EM)** for the remaining period 05years i.e., from **2025-26 to 2029-30** in respect of **St.Mary's EM High School, D.No.9-62, Rs.No.134&135, Kankipadu (V&M), Krishna District** vide reference 8th read above.
